- Overarching Regional Issues (if any)
- Goal 1- Resilient Landscapes
 - Key Risks, Barriers, and Critical Success Factors

 - Key Risks, Barriers, and Critical Success Factors
 - Key Opportunities
- Goal 3 Response to Wildfire
 - Key Risks, Barriers, and Critical Success Factors

(One idea is to combine parts of the regional summaries such as the risks, barriers, etc into a compare and contrast table that can be used to illustrate similarities and differences and highlight those areas that are similar for 2 or more Regions and possibly be addressed as national findings and be part of the basis for the national action plan).

3. National Findings from Regional Risk Analysis Reports

This section will list those priority risks, barriers, and critical success factors that two or more of the regions have in common and require one or more national level actions to address and resolve. This list will consist of a brief narrative description of each item. Details and approaches to addressing the National Findings will be presented in the Next Steps (section G) of this national report. D. - 1. Discuss how science has been used throughout the process to inform the CS.
- 2. Describe the comparative risk analyses, including the characterization of risk and a description of alternatives to address risk.

- 3. Key questions: Why is wildland fire an issue (why did we develop the CS?) How does wildland fire vary across the landscape and regions? How can our management actions mitigate the impacts of wildland fire nationally?
- 4. Summarize the alternatives, key findings, trade-offs and potential outcomes
- 5. Describe the National-level findings, trade-offs, investment options and potential outcomes across the nation based on the Regional Risk Analyses (address FLAME elements and GAO more completely than we did in Phase I).
- 6. Provide a range of information and explanations of the National Risk Analysis, alternatives, findings and conclusions that decision-makers at the National level (Congress, OMB, Departments, NASF, NGA, etc.) can use to make more informed decisions.
- 7. Need to look at regional reports to see how they impact the policy questions being addressed at the national level

E. Performance Measures (Sandy, Jenna, Ann, Tom Q, Larry Mastic, Dave Koch)

- 1. National long-term strategic outcome measures
- 2. Intermediate measures (time permitting)

F. Conclusions (Jenna, Ann, Alan; need to identify a WFLC or WFEC contact)

- 1. Describe the desired future state of the nation and how improvements identified in the National Risk Analysis can support the management of wildland fire.
- 2. Draw conclusions based on the findings considering investment options and list recommendations that could be made based on the regional and national analyses.

G. Document the Next Steps for the Cohesive Strategy (Dan, Mac, Jenna, Judith, Ann, Rachel, Shari) – Next steps should be tactical as well as strategic

- Discussion of key items in the National action plan and the results we expect to achieve by completing those actions. This will include the National Performance measures and objectives.

- 3. Acknowledge the data gaps within the analysis and that this is an iterative process (will be done again in five years). Provide recommendations for improvements or refinements in the data and science.

- 5. Discuss future governance
- 6. RSCs should review the National Risk Analysis to determine if the Regional Action Plans need to be modified.
