**Date:** November 15, 2013

**Subcommittee:** Cohesive Strategy Subcommittee (CSSC)

## Description of Issue or Assignment:

The Cohesive Strategy Subcommittee requests the input of the WFEC in determining the title for the Phase III Cohesive Strategy National Report.

## Discussion of Proposed Recommendation(s):

Two titles are being forwarded by the CSSC for consideration, not listed in preferential order:

### Option A:

*A National Cohesive Wildland Fire Management Strategy  
Final Phase: Risk Analysis and the National Strategy*

### Option B:

*A National Cohesive Wildland Fire Management Strategy:  
Challenges, Opportunities, and National Priorities*  
  
*(Subtitle) The Final Phase of the Cohesive Strategy*

## Identify Considerations:

Pros and cons have been identified for each recommendation.

### Regarding Option A:

#### Pros:

- Explicitly addresses the FLAME Act requirements to produce an analysis and strategy, and uses those terms consistent with the Act's language;
- Uses the term "the National Strategy" which is also used throughout the report;
- Title aligns better with the regional report titles (they are called analyses).

#### Cons:

- Doesn't directly convey key content/findings in the report, such as the national priorities which are a primary result of the report;
- Puts more focus on the risk analysis than the NSAT is comfortable with;
- Repeats the term "Strategy" in the title



# Proposal

## Regarding Option B:

### Pros:

- Is more descriptive of the key elements of value (i.e. Challenges, Opportunities, and National Priorities) that are derived from the analysis done for this report;
- Eliminates redundant use of the word "Strategy" in the title;
- Downplays the "analysis" portion of the report, which is simply a means to an end.

### Cons:

- Title does not conform to the FLAME Act stated purpose for this report;
- Does not contain the term "the National Strategy" although it is used throughout the report;
- Could set expectations that national priorities are being prescribed for the entire country (even though it doesn't actually prescribe anything specific for any part of the country).

## **Rationale for Recommendation(s):**

The CSSC wants to ensure that the title accepted for the report reflects the intent and direction of the WFEC.

## **Recommendation(s):**

The WFEC will discuss the recommendations offered by the CSSC and select their preference for the report title.
